

2018 Federal Tax Information

Your FAFSA was randomly selected by the U.S. Department of Education for a review process called "Verification." **Verification must be completed before your financial aid awards will be determined.** In order for NSCC to complete the verification process, we need you to complete <u>one</u> of the following:

- 1. Update your tax information on your FAFSA by using the IRS Data Retrieval Tool.
- 2. Submit a *signed* copy of the 2018 Federal Tax Form 1040 and Schedules 1-6.
- 3. Order your 2018 tax information from the IRS website. You can order your taxes by printing them online or requesting them to be mailed to the address on your tax return.
- 4. Submit the 4506-T Form to the IRS visit <u>www.irs.gov</u> to access the latest version of the form.

The preferred method is to use the Data Retrieval Tool, however, there may be situations in which the Data Retrieval Tool will not work and your only option will be to provide your Federal Tax Return.

Examples of situations in which you may be not be able to use the Data Retrieval Tool include:

- > Your marital status does not match your tax filing status
 - o Married filed separately; Single filed jointly
- You filed an amendment to your 2018 taxes. If you filed an amendment, please provide a copy of your *original* 2018 Form 1040 and Schedules 1-6 AND submit a signed copy of IRS Form 1040X to show the tax information that was amended.

IRS Data Retrieval Tool

- 1. Visit the FAFSA website <u>www.fafsa.ed.gov</u>
- 2. Click on the green **Login** icon and enter either your FSA ID or your name, social security number, and date of birth
- 3. Select the Make FAFSA Corrections link
- 4. Enter your Save Key then click **Next**
- 5. Click on the Financial Information tab



- Answer the questions regarding the Student/Parent Tax Information. After you have answered the questions, click LINK TO IRS.
- 7. Read the pop up warnings that appear to notify that you are leaving the FAFSA website and select **OK**.
- 8. Enter your tax filing information (name, status, and address) as it appears on your federal taxes *IMPORTANT* The information needs to match taxes exactly in order for the IRS to match your identity.
- 9. Check mark the box to **Transfer My Tax Information in the FAFSA**. Then select **Transfer Now**.

The tax information provided to fafsa.gov will populate the answers to the appropriate FAFSA questions. After the FAFSA questions are populated, your IRS session will end, and you will return to your FAFSA form. Check this box if you are choosing to transfer your information.

- 10. Your tax information on the FAFSA will display with bold indications stating **Transferred from IRS**.
- 11. If you are a dependent student, repeat steps for parental tax information
- 12. Click **Next** until you reach the **Sign and Submit tab**. Enter in your FSA ID and agree to the terms and conditions of the FAFSA. Click **Submit**.
- 13. Within 3-5 business days, NSCC will receive an updated FAFSA which will satisfy your tax transcript requirement on your myNSCC account. You will also receive a confirmation letter from the IRS confirming that your tax information was transmitted to your FAFSA.

Print your 2018 IRS Tax Return Transcripts Online

- 1. Visit the IRS website <u>www.irs.gov</u>
- 2. Click Get Your Tax Record
- 3. Select Get Transcript Online
- 4. Log In with your IRS log in information OR select First Time User

To log in as a first time user:

- Select **Continue** to proceed with Registration
- Select Yes for 'You Will Need Some Information About Yourself to Register"
- Select **Yes** for Financial Aid Account to Register
- Select Yes for Mobile Phone to Register
- Enter your personal information and select **Send Code**
- Enter your email confirmation code and select **Continue**
- Enter your personal information and financial account number and select **Continue**.
- Verify your mobile phone number and select **Send Message**
- Enter the 6-Digit Activation Code that will be sent to your phone and select **Continue**
- Create your user profile and select **Continue**
- 5. Once you have successfully logged in, select **Higher Education/Student Aid** as your "Reason for Transcript"
- 6. Select **2018 Return Transcript** *IMPORTANT* Make sure you turn off your pop up blocker! Your taxes will open in a browser. Please **print and submit to the Financial Aid Office**

Request your 2018 IRS Tax Return Transcripts To Be Mailed

- 1. Visit the IRS website <u>www.irs.gov</u>
- 2. Click Get Your Tax Record
- 3. Select Get Transcript by Mail icon
- 4. Enter your personal information then select **Continue** (if you filed jointly, the tax account data is listed under the social security number of the primary taxpayer shown on your tax return)
- 5. Select **Return Transcript** and the year for the Tax Return Transcript that you are requesting then click **Continue**

- 6. You should receive your Return Transcript in the mail within 5-10 business days.
